### We have always done it this way and we don't intend to change - ever.....

A few years ago I was asked to present the extended second degree working tools which I believe is a lovely piece of ritual and ideally suited to what is a fairly short ceremony. After the meeting I was taken to one side and told that 'this Lodge doesn't do that piece of work'. As I walked away, I thought how sad that the members of the Lodge are restricted to a diet of ritual dedicated to preserving ceremonies which countenance no variation whatsoever, and devoid of the beautiful prose to be found in the Long Closings, the very emotional Walking Charge of the Third Degree (ask W Bro Colin Davies to do it for you), and the cleverly constructed Mode of Preparation which explains so much to the newly Initiated Freemason.

Sometimes tradition, as in 'this is the Lodge's tradition established by the founders' - is used to counter any attempt to change the content, no matter how minor, of a ceremony. It's bit like 'we must have parsley sauce with ham' at the festive board as it's traditional, even though many would prefer it to be a choice and not imposed. I wonder if anyone ever stops to think 'I wonder what the Brethren might like'?

Perhaps a younger/junior Brother has seen or heard something different during a fraternal visit elsewhere, and wants to ask whether his Lodge might consider doing the same; If he thinks his request/suggestion will be disregarded or worse he will suffer some form of admonishment, what do you think he will do? And before someone says 'that would never happen' let me assure you, it does and it has.

Change is not always easy to accept, but occasionally doing something different needn't be the end of the world either. In fact it might just be the very thing to breathe new life into the Lodge. What possible harm can there be in a Master introducing an occasional one-off 'variation' during his year in office?

Why not make a new year's resolution to try something new in 2018?
