In October I will Appoint and Invest Gary Dolphin (Gooch Lodge No.1295) as the Provincial Grand Almoner, and I am confident he will continue to uphold the fine traditions and excellent work established by his predecessors.

Sally and I were delighted to attend the charity evenings held at Calne and Salisbury at the end of July. The events enabled charities to talk with Lodge Charity Stewards and explain the vital work they undertake in the community. I was able to thank each of the charities for attending and assure them of continuing Masonic support for their activities. It was good to hear from the many Lodge members who attended the evening who told me how much they enjoyed meeting and talking to the volunteers from the charities.



Talking of support, a huge thank you to those Brethren who gave some of their precious weekend time to assist the Communication Team when they brought the Provincial Display unit to Salisbury for its third visit in as many months. The unit has certainly helped to promote Freemasonry in the City.

### The Master rules and directs his Lodge.....

But does he, or is he allowed to? Well, surely there can be no doubt, after all isn't it the case that a new Worshipful Master, regularly installed, is given complete authority by the Lodge members who elected him to make any such changes as he sees fit? Well, he might well think that to be the case, and there is little doubt the Book of Constitutions makes clear that the Master of a Lodge has very extensive powers. It is also clear that custom and practice place degrees of restraint on the over exuberant exercise of such powers, and it would be a brave (and perhaps foolish) Master who attempted to use more than a fraction of them other than in exceptional cases. However, under Rule 114 *'The Master is responsible for the due observance of the laws by the Lodge over which he presides'*. The 'laws' referred to are those set out in the Book of Constitutions, the Lodge By-Laws, and the By-Laws of the Provincial Grand Lodge.

The Master is not only responsible for 'due observance of the laws' he is also bound to support all of the Ancient Charges read to him on the occasion of his Installation. Charge No.5 reminds him that he *'will submit to the awards and resolutions of your Brethren in general Lodge convened.'* Most Masters appreciate the reality of their new situation, which is not that of a monarch, even less that of a dictator (benevolent or otherwise); to quote from *The Preceptor's Page* (see Provincial Website) on this theme by W Bro. Michael Lee, *"He is proudly and happily - but merely - first amongst equals"*.

At this point it is perhaps appropriate to make reference to what is without doubt one of the most pleasant privileges of a Master Elect, that being covered by Rule 104 (e) *'The appointment of all Officers except The Master, the Treasurer and (if elected) the Tyler, is at the sole discretion and power of the Master'*. A wise Master will work with that skill and assiduity which maintains the honour, reputation and usefulness of the Lodge; likewise he will ensure the happiness of its members by his zeal and ability to promulgate the genuine principles of Freemasonry. What is true of the Master is equally true of his officers, particularly those who have responsibility for the administration of the Lodge affairs and the deeply moving aspects of its beautiful ceremonies who should work with the Master to devise a Lodge programme for the ensuing year. After all isn't the purpose of our meeting together made clear, *'I therefore trust that we shall have but one aim in view, to please each other and unite in the grand design of being happy and communicating happiness'*

But what happens when the natural order of things is fractured, and an element within the Lodge seek to regulate affairs and indeed dominate the business and running of the Lodge; all incidentally predicated on what are ostensibly genuinely good intentions? A reminder of the words found in the Address to the Brethren may well be timely. *'The Brethren whom the Worshipful Master has selected to assist him in the ruling and governing of the Lodge are too well acquainted with the principles of Masonry, and the Laws of our institution, to warrant any mistrust that they will be found wanting in the discharge of the duties of their respective offices, or that they will exceed the powers with which they have been entrusted'* Yet we all know that it is far too easy to move from a position of helping and assisting, to one of controlling and taking charge.

Just as the Master does not have absolute power over the affairs of the Lodge, the same is true for any other officer, and this principle can even be brought to bear on Lodge Committees which are specifically mentioned in Rule 154 and can be further explained thus: *'The Lodge by resolution may specifically refer any other matter to such a Committee (of which the WM is ex officio and presides over) for consideration and report or with power to act within such limits as the Lodge may define, but no Committee may be invested with any general executive powers'*. This simple sentence makes all very clear. A Lodge Committee may recommend change, but is not empowered to make change. Due Notice of Motion for any change must be properly given


