#### The summer break is an illusion....



Well, it is for many of the team who have been busy working behind the scenes and getting ready for, yes you have guessed it, the start of the new Masonic season in September, and in particular the introduction of HERMES.

I am sure you will recall that in June's edition of InTouch>OnLine I mentioned the impending visit of the London HERMES team to Cricklade when they hoped to finalise the details for the implementation of HERMES across the Province. I am glad to be able to report the visit took place and Steve Lee's team was able to discover more about the system that will be the basis for the way in which Lodges and Chapters will conduct their administrative work for the future. Following the meeting Steve and his team have been testing HERMES using a 'sandbox' training

environment to hone their skills and to identify the areas that might generate the greatest number of enquiries and questions from the users.

Lodge and Chapter administrators have been sent the necessary details to enable them to access the learning platform which will allow a great opportunity to explore the HERMES system in preparation for our 'go live date'.

I know that some Secretaries and Scribes will be wary of the system and the requirement to change practices that had become second nature to them. I am also aware that HERMES is not a perfect solution, but the simple truth is that HERMES is the system that we and other Provinces throughout England and Wales will have to use as from the 12th of August. My ask of all of our Secretaries and Scribes is that you engage with the team and embrace the positives that exist within the HERMES system.

The Provincial Grand Director of Ceremonies Barry Jordan-Davis and his team will be welcoming their Lodge counterparts to Devizes on Wednesday 17<sup>th</sup> July at 7.00pm. This will provide Barry with the opportunity to outline the Province's role in maintaining and improving standards of ceremonial, and also to hear the views of the Lodge Director Ceremonies. As a former Director of Ceremonies I am keen to see our Lodges promoting excellent standards of ceremonial, not necessarily to the standard of the troops at the recent Sovereign's Birthday Parade, but somewhere close would be very nice.

I have asked the Provincial Communication Officer to liaise with Lodges to review their by-laws and bring them up to date and in line with the UGLE model by-laws. I was pleased to hear that a number of Lodges have already updated their by-laws and adopted the new Provincial format which will ensure uniformity in presentation, while others are preparing to submit a motion to the Lodge outlining the changes. In the main, this exercise will enable Lodges to assess whether fees for Initiates, and Joining members are sufficient to cover costs; it will also provide the opportunity to ask whether the by-law relating to Country Membership is relevant for your Lodge. Please do contact Des to discuss how easy it is to carry out a review and to make any changes.

In the Summer 2024 edition of Across the Plain Colin Cheshire outlined how his team handle Membership Migration, that is when a Lodge member leaves the area and wishes to join a Lodge or Chapter close to their new home. The role of the Membership team isn't just about 'attraction' and I would urge Lodge Secretaries, Membership Officers and Mentors to keep Colin informed of any Brother moving away from the Province.

#### Always Better....

You may recall the words of the Pro Grand Master some time ago when he said "it is not a capital offence to smile during a Masonic meeting". He did go on to say "don't make it a pantomime" which comment emphasises the serious aspect of what we do.

I think everyone will agree that good ceremonial really does add to the experience of a Lodge meeting. For this to happen requires the Lodge Director of Ceremonies to make sure the ceremonies proceed smoothly and are carried out in a dignified manner and to the highest possible standard. Being a good Director of Ceremonies requires many attributes including an absolute need to be knowledgeable about the ritual practiced in the Lodge; tactful in his dealing with the Brethren and above all he should set the tone of the Lodge by personal example. The role of the Director of Ceremonies in supporting the Brethren of the Lodge in both the Lodge Room and the Dining Room cannot be overstated.

Barry Jordan-Davis will be welcoming your Lodge Director of Ceremonies to join him and his team in Devizes on Wednesday 17<sup>th</sup> July when the overall theme of the meeting will be ALWAYS BETTER recognising that and is inviting them to **Ask a Question** on any matter related to their duties in the Lodge. 

#### Why your by-laws are important....

Every Lodge has the power of framing proper by-laws for its government, that's a fact established in Rule 136 BoC. However, the opening sentence is not the whole of the rule, as a famous comedian (Jimmy Cricket) was prone to say, "There's more." The more in this case is that no by-law or any alteration thereof shall come into operation until approved on behalf of the Grand Master.

In the case of by-laws or any alteration conforming to the model by-laws, approval can be granted by the Provincial Grand Master. If the new by-laws or any amendment does not conform to the model by-laws it **must** be approved by the Grand Master. Clearly, it is in everyone's best interest that by-laws and any amendments conform to the UGLE model by-laws. First, no one wants to play email ping pong, it's a distraction and achieves little. Secondly, the UGLE secretariat is a remarkably busy section of the organisation and there are no guarantees of timeliness with regard to approving documents; and thirdly, given there is a noticeably clear and logical template that when used dispenses with any delay, why not take advantage of it, and use it.

As with all things Masonic, there is a process to be followed before any by-law or amendment can be proposed in open Lodge for the members approval. The Communication team has produced a comparison template in which the current by-laws can be compared to the new by-law. This has proven to be a positive way to communicate with the Lodge and conform to the requirement of by-law 11 (a).

The Provincial Grand Master refers to the design format that the Province has asked Lodges to adopt. This is simply an A6 booklet with a cover featuring the Lodge name, number, and logo; and the Wiltshire shield and the words 'Province of Wiltshire.'

The Communication team has sourced a printer that has proved competitive against quotes provided by other potential suppliers.









#### **Teddies for Loving Care...**




#### The Royal Arch....

The rules in the Book of Constitutions regulate Craft Lodges, while in the Royal Arch the corresponding rule book is the General Regulations that date from 1817 and which can be found positioned at the back of the Book of Constitutions. It will come as no surprise to discover that the Royal Arch Chapters manage to function with 73 Rules covering 20 pages, while the Craft Lodge has 98 rules covering 60 pages. However, as every Freemason will know it's the interpretation of the rules, and regulations that provides the basis for healthy and frequently spirited debate.

Many of the regulations governing the Royal Arch are almost identical to those found in the rules of the Craft, one in particular comes to mind. Just as the Master of a Craft Lodge can only be elected to office for a period of two years in succession, so the same applies to the Royal Arch First Principal. Should the Brethren or Companions wish the Master/First Principal to undertake a third year, a dispensation must be obtained from the Provincial Grand Master/Grand Superintendent. But what about the Second, and Third Principal, is their route to the Chair the same as for Wardens in the Craft - and what about the other Officers of the Chapter, how different is their appointment?

You can discover more about the Royal Arch, its history, its place in Freemasonry, its differences and its similarities, from the most reliable source of all - Royal Arch Masons including Grand Superintendent John Reid, Deputy Grand Superintendent Simon Ellingham, and members of the Provincial Team.
