### Well, we've got to February...



And what a start to the year we've had. I am so pleased that all of our Lodges and Chapters hit the ground running with ceremonies, lectures and other interesting events, and looking at Paul Robinson's calendar for February I'm persuaded the level of momentum will be maintained. It is particularly gratifying to note that we have nineteen new Initiates being welcomed into Wiltshire Freemasonry, and four Exaltees being received into the Royal Arch.

Under the chairmanship of RW Bro John Thompson PrGM for Durham the United Grand Lodge of England will be applying to be awarded Gold status in 2025. Watch this space.

I trust all of our Members will have received an email from the Communication Team asking them to 'sign up' to Portal. Described as a personalised doorway to the future of Masonic membership, Portal is YOUR doorway and you will have the key to open it and to store your personal data. Portal will transform how you interact with your Masonic journey, giving you easy access to all the information you need and empowering you to take control.

Security and privacy are features that everyone quite rightly demands and you will be pleased to know they have been built into the very foundation of Portal. You, as the owner and user of your data will be in complete control of your personal information. Its accuracy will be entirely dependant on the quality of your input and it will also be your decision who sees the information on the system. However, this is only phase one, there's more to come and future phases are already being worked on and will include the provision of support to Provincial, Lodge, and Chapter Secretaries.

If you haven't yet signed up to use Portal please do so as soon as possible. It really is easy to do, blissfully simple to use and it will be a real boon to your Secretary to know that Members are maintaining their personal data.

### The Risings and the Lodge minutes...

The Risings are the recognised method of bringing to the attention of the Lodge any business that is not dealt with by the agenda. Frequently on a Lodge agenda the rising are preceded by the words 'Any Other Business' a term that is neither required or necessary as it is in the Risings that any other business is conducted. The actual business dealt with under each of the three Risings follows a familiar pattern. Under the first Rising correspondence and communications from Grand Lodge are dealt with, the second Rising to communications from Provincial Grand Lodge, and on the third Rising any other matters such as propositions and apologies. It is on the third Rising that visitors (not members) are invited to convey greetings from their respective Lodges. Note: there is little need for a member to give greetings, as he is obviously well known.

The other term used on some Lodge agenda's is 'Matters Arising' out of the minutes of the previous meeting. This is quite a strange item, not least as invariably the Secretary simply stands and declares "there are no matters arising - Worshipful Master'. He is quite correct as the minutes of the meeting once 'confirmed as a true and accurate record of what then took place' offer no reason for further comment. If there had been an error in the minutes, such an error must of necessity be reported to the Secretary before the meeting at which they are presented as once confirmed they cannot be amended. The minutes do not deal in opinion, only in fact, they are a record of what took place on the occasion of the meeting.

### **Unauthorised Charity Appeals...**

Occasionally Members seek to enlist the support of other Members and Lodges to raise funds for worthy causes and charities. It is worth repeating the guidance given by UGLE with regard to such appeals. "It is irregular for any appeal to be made to the Craft is general to support particular objects, causes, or movements without the sanction of the MW Grand Master, or, in the case of any such appeal intended only for circulation in a specific Province, of the Provincial Grand Master." ### Raising funds for the ABF

The Sandakan Death Marches were a series of forced marches in Borneo from Sandakan to Ranau which resulted in the deaths of 2,434 Allied prisoners of war held captive by the Empire of Japan during the Pacific campaign of World War II at the Sandakan POW Camp, North Borneo.[1] By the end of the war, of all the prisoners who had been incarcerated at Sandakan and Ranau, only six survived, all of whom had escaped. It is widely considered to be the single worst atrocity suffered by servicemen during the Second World War.

To raise money for the ABF: between **7** and **16 March 2027** Brother Gary Logie (Lansdowne Lodge of Unity, No. 626) will be retracing the steps of the Prisoners of War, who endured extreme conditions on the gruelling Death March from Sandakan PoW camp to Jessleton in 1943. 470 prisoners set off, only 6 survived.

The Army Benevolent Fund (ABF) aims to provide soldiers and veterans with the means to live independently, and with the dignity they deserve.

For some Army veterans, injury, disability and advancing years can make it difficult to remain independent and to stay living in their own homes. The ABF stands at the forefront of support for the Army family, last year supporting an estimated 75,000 people in 51 countries around the world. As one of the largest funders in the sector, they award grants to individuals and families, and fund leading organisations that support

soldiers, former soldiers, and their families

For some Army veterans, injury, disability and advancing years can make it difficult to remain independent and to stay living in their own homes. The ABF is on hand to support veterans and their families, both young and old, with home adaptations and mobility equipment that enable them to live where they have the best quality of life. Some will require significant support for the rest of their lives, and the ABF is there to ensure their needs are met over the long term.

The ABF provides support for soldiers, for life, making sure that veterans and their families have the care they need, long after service has ended.

Supporting the Army family is central to the work of the ABF, enabling better mental and physical wellbeing, so that soldiers, veterans, and their families can lead healthy and fulfilling lives.

For some, leaving the Army is a daunting experience, we are here to provide lifelong support for those who have served their country and who find themselves in particular need of help; the wounded, injured or sick who have had to leave the Army through no fault of their own.

### **Annual Provincial Subscriptions....**

Just as paying your individual Lodge subscriptions on time is very much appreciated by the lodge Treasurer, so too is paying the Province the annual Lodge subscription. This year is the first time HERMES has been used to issue the Annual Return and the subsequent invoice and the Provincial Treasurer is delighted with the response from Lodges throughout the Province who have made prompt payment.

#### A Reminder...

Past Masters who have been presented with a Past Masters breast jewel are asked to remember that in this Province the wearing of Lodge specific jewels is restricted to the Lodge to which they apply; which means that when a member visits or joins another Lodge he does not wear a Past Master's or a Centenary breast jewel of another Lodge in that Lodge.

If you invite a member of another Province to visit it is perfectly in order, and a courtesy, to advise your guest of this ruling. A Freemason will not be offended at being made aware of this and in most circumstances would be grateful for the notification. A similar principle applies when visiting a Lodge in another Province; please make yourself aware of the policy of the Province and be respectful of their wishes.

#### The Festive Board...

One of the most enjoyable features of a Lodge meeting is the time spent socialising with our fellow Brethren at the Festive Board or as it is commonly referred to 'the after-proceedings". It will come as no surprise to discover that the Book of Constitutions offers some good advice regarding the correct behaviour to be followed.

"You may enjoy yourselves with innocent mirth, treating one another according to ability, but avoiding all excess, or forcing any brother to eat or drink beyond his inclination, or hindering him from going when his occasions call him, or doing or saying anything offensive, or that may forbid and easy and free conversation; for that would blast our harmony, and defeat our laudable purposes." **The Charges of a Free-Mason - V1 Of Behaviour.** 

While a little humour often helps in lightening a speech, particularly at the toast to the visitors or in the response, this should be used carefully. A little wit, an elegant and eloquent turn of phrase, even if designed to elicit a 'groan' are all acceptable. A joke or a story, however, is a different matter. These are, on the whole best avoided altogether, for the straightforward reason that junior Brethren are liable to think that telling a joke is the thing to do. This leads too easily to someone trying to cap an innocuous story with a slightly risque one, or even worse, one that is definitely of a dubious nature; at which point we move into 'being offensive'.

The most important rule when making or responding to any toast, is to keep it short. The very best of speakers, by leaving listeners wish he'd gone for longer, will only enhance his reputation.

To be able to access Portal it is important that your email address is up to date with UGLE and recorded properly on the Adelphi database. Your Lodge Secretary or Chapter ScribeE can help by checking and updating your email address - it's always worth confirming with them that they have the right details.

While every Freemason will be invited to sign up to Portal, use of the system is voluntary. If you choose not to use Portal, your Lodge Secretary will be able to update your personal data using HERMES. #### Serving the local community in Chippenham...

On Monday 25<sup>th</sup> November 2024 the country felt the full force of Storm Burt with Wiltshire being subject to severe flooding, locally one of most affected areas was Chippenham where the town centre found itself underwater on after downpours caused the River Avon to burst its banks.

Shops on the High Street were forced to close while important routes into the town centre were also impassable, like The Bridge Centre Roundabout, and were closed by police.

While the water was cleared by Tuesday morning, businesses were left reeling in the aftermath of what many have described as the worst floods in Chippenham since 1968 and residents were left shocked by the floods that submerged the town centre overnight.

One of the many organisations affected by the flooding is the local squadron of the Chippenham Air Cadets whose main building and storage containers were submerged under four feet of water. The inevitable loss of uniforms, teaching equipment, first aid teaching kit, furniture and technological equipment, much of it either gifted, donated or bought through cadets fundraising activities was to have a marked effect on the cadets.

The unit provides a space for young more than 40 young people twice a week, many of whom aspire to join the military. The squadron has a long history in the town and is proud to count fighter pilots, Falklands veterans and airline pilots among the thousands who have been a part of it over decades at the current site on Long Close and before that.

A call to arms was made on behalf of the Air Cadets and Chippenham Masonic Centre members Lansdowne Lodge No.626 and Vale of Avon Lodge No.8432 (both of which have former cadets in their ranks) responded with the offer of the lower hall whilst their meeting place is rebuilt. As it turns out this journey hasn't all been straight forward as the initial ask of a couple of months is now 12 months as the meeting hut requires rebuilding.

The first challenge: The RAF and ATC are only geared for hiring public spaces which comply with certain regulations. Using a private Masonic meeting hall was something they have never done before and required the CMC to refresh its building certificates, and put new policies in place (a not insignificant amount of work).

The second challenge: The CMC and the ATC hit a roadblock as RAF policies stipulate a recent Wiltshire Fire Rescue Service Fire Risk Assessment was to be undertaken before the venue could be used as a temporary home for the cadets. We asked the ATC if they could find a pragmatic solution and a way forward and that arrived in the shape of Bro Rick Whitehead (The Border Lodge No.3129 – and more importantly ATC's Regional Safety Advisor) whose involvement completely turned the situation around. He put in a significant amount of work getting the Fire Risk Assessment complete and gained agreement from ATC leadership to allow the ATC to use the hall.

The current challenge: The challenges are not over as we still need to get our Commercial Electrical Safety certificate refreshed if the Cadets are to be allowed to Parade at the CMC beyond Mid-February.

But there is an upside to all this work and that is that the CMC will now be able to better support its orders when they want to work with the community around the building with a complete set of building certificates, policies, and procedures.
